The West Virginia Athletic Directors Association would like to invite every high school and middle school athletic director to attend the 39th annual conference at the Charleston Marriott on April 29 through May 1. A committee met to arrange the conference and we feel that we came up with an excellent agenda for the meeting.

The conference will begin with a golf outing on Saturday morning, April 29th. At this time no course has been secured for this tournament but we will let you know where we are going to play as soon as we find out where we will play. We hope many of you will be able to participate..

At 12:00 the Leadership Training Class 501-Athletic Administration: Guiding Foundations and Philosophies will be taught. The registration fee for the class is \$85.00 for members and \$100.00 for non-members. LTI 501 is a required class for taking the CAA exam and gives you information on the organization of the WVSSAC and NIAAA that are part of the primary organizations that WVADA are involved with and the leadership of these organizations. Please sign up by April 17th. I hope many of you will plan to take one of these classes at the conference.

At 6:00 the Conference Banquet will begin. The Charleston Marriott will be the site for our banquet. The main focus of the evening will begin with the presentation of the Distinguished Service Awards to five individuals outside the field of education who have contributed to the athletic programs and to their communities. Also, the West Virginia Athletic Directors Association High School and Middle School Athletic Director of the Year will be honored along with the National Interscholastic Athletic Administrators Association Award of Merit. The WVADA will present \$500.00 scholarship to the male and female scholar-athletes for this year. After the banquet the WVADA will provide a hospitality room for everyone in attendance.

On Sunday morning we will begin our agenda. At 8:00 am we will offer NIAAA Leadership Training Course: 504-Athletic Administration: Legal Issues I — (Liability for Sports Injuries and Risk Management). This is a required class for a person desiring to attain their CAA certification and is a great class and it is good for all athletic directors. At the same time as LTI 504, LTI 610: Today's Athletic Technology Solutions for Productivity and Communications will be taught for attendees who have already taken LTI 504. This is a hands-on course on how to use apps for productivity and communications in your job as an athletic director. A computer is required for this course. The registration fee is \$85.00 for members and \$100.00 for non-members. A.D.'s who previously have taken any of the LTC classes have considered them to have been very useful and beneficial. The class will be over at 12:00 and our regular agenda will start at 1:00 with the first session. Exhibits will be open at 10:30.

The conference registration will begin at 1:00 and exhibits will be open for viewing. The conference will begin at 1:00 pm. Session #1 will feature Phil Rison NIAAA Assistant Executive Director in Indianapolis, Indiana. Phil will give us an inspiring Opening Session talk and some insight into the working of the NIAAA. This will be followed by John Crosby from South Carolina, talking about "Play Safe" a new approach to placing athletic trainers in our schools. It will be interesting approach to a problem for many schools in West Virginia. Session III will feature Justin Miller from Salt Lake City, Utah, talking about "Understanding and using Arbiter" This new method of paying officials is used by many schools but more information may be needed. Session IV will be Sean McAndrews, Compliance Director from West Virginia State University talking about changes to NCAA Eligibility Rules that are taking effect this year and next. This is very important for the athletes in your school. Session VI will be the ever popular Round Table Discussion moderated by Steve Campbell from Musselman H.S. and we will focus on problems that athletic directors may have. Have questions to ask. The hospitality room will be open during the evening.

On Monday morning, the day will begin at 7:30 with a conference breakfast. We hope you will attend and then be prepared for the business meeting which will follow the breakfast at 8:30. A caucus will be held after the business meeting to select a regional representative for Region 3 & 4 and President-Elect for the next two years. Session VII will begin at 9:30 Mark Moore from the West Virginia Department of Education. He will present a follow up on a session from last year about Office 365 which is available to all teachers in West Virginia. The last session will feature the WVSSAC Executive Director, Bernie Dolin and his staff talking about the WVSSAC and changes that may have come about in the last year. They will try to answer questions about the new proposals that were approve at the recent Board of Control Meeting and other questions you many.

LTC Classes

Earlier I gave you information regarding the Leadership Training Classes that will be taught during the conference. On Saturday at noon LTI 501- Athletic Administration: Guiding Foundations and Philosophies On Sunday at 8:00 LTI 504: Legal Issues I (Liability for Sports Injuries and Risk Management) will be taught. Also on Sunday at 8:00 LTI 610: Athletic Administration-Today's Athletic Technology Solutions for Productivity and Communications will be offered as an option for A.D.'s that may want to take it or may already had LTI 506. Cost per class is \$85.00 for WVADA members and \$100.00 for non-WVADA members. Registration for the Leadership Training Class is April 17th so we can get the material ordered for the class.

CAA Exam

Any A.D. interested in taking the CAA Exam is required to have taken LTC 501, LTC 502, LTC 504 and LTC 506 in order to qualify for taking the test. If anyone is interested in taking the exam you need to file the necessary paperwork, at least one month prior to the test, with the NIAAA. We now have several A.D.'s in West Virginia with the CAA designation and we hope more of you will consider taking the exam and become a Certified Athletic Administrator. More information will be provided at the conference. Note: Starting in December, CAA exams will be by computer and there is talk about adding LTI 503 (a new class) as a requirement for CAA certification. One additional note: The Board of Directors agreed to reimburse the next ten athletic directors to earn their CAA or CMAA \$150.00 of their cost for classes toward the certification. Proof must be presented showing completion of the certification. This is an incentive to earn this certification as soon as possible. We currently have awarded two completers with this reimbursement.

Pre-Registration

Conference registration is due by April 10th. Pre-registration is \$140.00 for members and \$165.00 for non-members. Late registration is \$165.00 for members and \$190.00 for non-members. Retired members pay \$60.00. Extra banquet tickets are \$40.00 for spouses or guest. As part of your conference registration fee your WVADA dues for 2017-18 school year will be included. Your NIAAA dues are \$80.00 and you have the option of paying with your registration if you would like to pay them at the same time. Remember that NIAAA dues are for one calendar year from when you last paid so if you joined in October, for example, you will not pay your dues again until October. Also, remember that your banquet ticket, conference gift and Monday's breakfast are included in your conference registration.

Exhibitors

If you want to bring a guest to the banquet the ticket will cost \$40.00.

Requirements for receiving free conference registration. First time attendees must pre-register for the conference and attend the entire conference. They must register for at least one Leadership Training Class (at the conference on either Saturday or Sunday) to qualify for the free registration. No free registrations at the conference site.
