Regional Tournament:

1. The Board of Directors will be responsible for the selection of site, time, date (**Week 47**), pairings, admission fee and tournament director.
2. **Director's Responsibilities:**
 - a. You are acting as the WVSSAC representative; therefore, please see that all rules and regulations are followed.
 - b. Arrange for all needed support personnel. (official scorer, ticket sellers/takers, security, medical, etc.)
 - c. Select **officials** for the games (**must be Class I or II**). Try to work with participating schools for the selection; however, the final decision will be made by you.
 - d. Baseballs will be purchased by the director and subtracted from the gross receipts. The adopted state baseball (**Wilson A1010 Pro**) must be used.
 - e. If there are changes due to weather conditions, please give adequate notice to participating schools, officials and media.
 - f. The established admission price will be:

Adults	- \$6.00
Students	- \$5.00
 - g. Give State Tournament Rooming List Information and other information provided by the WVSSAC office to state qualifier.
 - h. At the conclusion of the tournament you will:
 - 1) Complete the Financial Report Form and forward a copy to the WVSSAC (**Form Ba 3**).
 - (a) Finances - To be fair to participating schools, a financial report will be prepared for each regional game. Profit or loss shall be shared by the teams in each game.
 - (b) Be sure to send a check for \$45.00 for the championship plaque to the WVSSAC. Each regional site will share in cost. (i.e. one game 1/3, 2 games 2/3 cost.) (**There will be no charge for for plaques for 2007-2008**)
 - 2) Notify the WVSSAC office of the name of the winner.
 - i) Revenue generated from radio broadcasts are to be shared between participating schools.
